It is hereby acknowledged that the Highway Commissioner has the authority to issue, or withhold, such permit at his discretion or, if such permit is issued, to prescribe the route or routes to be traveled; to limit the number of trips, to establish the time or seasonal limitations within such vehicles described may be operated on the roads indicated; or otherwise limit or prescribe the size or number of loads, route or routes to be traveled and to determine any conditions of operation for such vehicle, or vehicles, to protect the road foundations, surface structures, shoulders or drainage, and to insure against undue damages, and may require such undertaking or surety as is necessary in his opinion, to compensate for any injury or damage to a roadway structure. Every permit, or a copy of the permit, will be carried in the vehicle or vehicles to which the permit refers, and shall be open and available to any police officer or authorized agent of any authority concerning the roadway. No person shall violate the terms and conditions of the permit.

Whenever any vehicle or vehicles are moved or operated in violation of this permit, the person to whom such permit is issued, in addition to the driver of the vehicle, is guilty of such violation, and

either, or both such persons, may be prosecuted for such violations. This permit does not grant, or imply, consent or approval for any other permits or requirements that may be required by any other governmental agency or body.
