TAX LEVY ORDINANCE

PALATINE TOWNSHIP ROAD DISTRICT

ORDINANCE NO. 09-16 RD

AN ORDINANCE levying taxes for all road purposes for Palatine Township Road District in Cook County, Illinois, for the tax year 2016, collectable in 2017.

BE IT ORDAINED by the Board of Trustees of Palatine Township, Cook County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Palatine Township Road District on December 19th, 2016 does hereby determine and declare that the sum of two million five hundred eighty thousand dollars (\$2,580,000.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as defined in the General Road Fund for fiscal year 2017.

SECTION 2: That the amount levied for each object and purpose shall be as

I, the undersigned, hereby certify that I am the presiding officer of, Palatine Township, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

- O The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
- The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- O The proposed aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. - O The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the Truth in Taxation Law.
