

BUDGET & APPROPRIATION ORDINANCE

PALATINE TOWNSHIP ROAD DISTRICT

ORDINANCE NO. 01-23 RD

AN ORDINANCE appropriating funds by Palatine Township Road District, Cook County, Illinois, for the Fiscal Year 2024 (FY2024) beginning April 1, 2023, and ending March 31, 2024, tied to the Tax Year 2022 (TY2022), collecting in 2023, for the jurisdictional maintenance of the public right of way.

BE IT ORDAINED by the Board of Trustees of Palatine Township, Cook County, Illinois, as follows:

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of Palatine Township Road District, be and the same are hereby appropriated for road purposes of Palatine Township Road District, Cook County, Illinois, as hereafter specified for the Fiscal Year 2024 (FY2024) beginning April 1, 2023, and ending March 31, 2024.

SECTION 2: That the following budget containing an estimate of expenditures and revenues is hereby adopted for the following funds,




SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That each appropriated fund total shall be divided among the several objects and purposes specified, and in the particular amounts stated for each fund respectively in Section 2 constituting the total appropriations in the amount of *two million, three hundred and four thousand, three hundred and fifteen dollars* (\$2,304,315.00) for the Fiscal Year 2024 (FY2024) beginning April 1, 2023, and ending March 31, 2024.


SECTION 6: That section 3 shall be and is a summary of the annual Appropriation Ordinance of this Road District, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.

SECTION 7: That a certified copy of the Budget & Appropriation Ordinance must be filed with the Cook County Clerk within 30 days after certification.


