

BUDGET & APPROPRIATION ORDINANCE

PALATINE TOWNSHIP ROAD DISTRICT

ORDINANCE NO. 01-26 RD

AN ORDINANCE appropriating funds by Palatine Township Road District, Cook County, Illinois, for the Fiscal Year 2027, beginning April 1, 2026, and ending March 31, 2027, funded by the Tax Year 2025, collected in 2026, for the jurisdictional maintenance of the public right of way.

BE IT ORDAINED by the Board of Trustees of Palatine Township, Cook County, Illinois, as follows:

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of Palatine Township Road District, Cook County, Illinois, be and the same are hereby appropriated for the jurisdictional maintenance of the public right of way of Palatine Township Road District, Cook County, Illinois, as hereafter specified for the Fiscal Year 2027.

SECTION 2: That the following budget containing an estimate of revenues and expenditures is hereby adopted for the following funds,


SECTION 5: That each appropriated fund total shall be divided among the several objects and purposes specified, and in the particular amounts stated for each fund respectively in Section 2 constituting the total appropriations in the amount of *two million, four hundred and nineteen thousand, one hundred and seventy dollars* (\$2,419,170.00) for the Fiscal Year 2027.

SECTION 6: That Section 3 shall be and is a summary of the annual Appropriation Ordinance of this Road District, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.


SECTION 7: That a certified copy of the Budget & Appropriation Ordinance must be filed with the Cook County Clerk within 30 days after certification.
